Selection Process: Applications will be reviewed by the BEP committee based on responses to the application & interview questions. Applications will be received at Bayview Baptist Church business office by July 25th, 2008. Please mail or bring to:

Selectees: The BEP committee will select:

- 1) Three (3) candidates to participate in a year-long (12-month) giving/savings plan.
- 2) All participants, including the intended recipient, will have agreed to contribute a set amount of money each month toward a goal of up to \$12,000 for the year. You can partner with others to obtain an optimum \$50.00 a month contribution.
- 3) At the end of the 12-month period, the selected recipients will split whatever contributions are given by fellow Bayview membership.
- 4) The chosen candidate recipients must agree to abide by the BEP stipulations and sign an agreement contract.

Eligibility: To qualify for the BEP, the candidate/s must be a Bayview Disciple &:

- 1) Have completed Bayview Discipleship & Christian Enrichment classes
- 2) Completed Crown Ministries, or agree to complete within the 12-months
- 3) Be actively participating in at least one Ministry
- 4) Practice the first principle of Christian Money Management of giving to God first
- 5) **Have insufficient income to meet basic needs; or**
- 6) **Saving for a down payment on a 1st home purchase. If selected as a BEP recipient, you agree to commit to an additional year as a volunteer in a selected combination of the following: volunteer services as a coach, mentor, prayer partner, help with group organization, and/or contribute as a monetary giver to a new BEP recipient.**

If you are **not** selected as a BEP recipient in one year, you may re-apply again in the following year's BEP venture. However, once you have participated as a recipient, and received BEP funds, you are no longer eligible for future BEP gifts.

If you must drop out of the BEP for whatever reason, you may re-enter in the next year, providing your situation falls within specific parameters. Monies already contributed by you will be kept in trust for use within the next BEP cycle. If it's impossible for you to re-enter the BEP, money already contributed is non-refundable.
